contraceptive operations in order to prevent successive births of kittens. But we think that Kawasaki city administration has the responsibility in bearing this, because this is caused by the project headed by the city. This same problem has occurred everywhere in the city in the past and every time it was the citizens who felt pity for the miserable strayed cats making them take care of the kittens. This reflects the reality in which the city administration puts no budget for this type of situation. (Please see attached example)

2) Placing temporary shelter for the refuged animals

It is inevitable that the cats which lost the place to live wander into the surrounding residential area to seek for food. Even at present, the troubles concerning strayed cats often occur in this area.

3) Proper Management of the refuged animal shelter. (Under homeless supervision)

- 4) Set up of the feeding area
- For the cats which can't be refuged in the shelter, a feeding area must be setup, with undergoing contraceptive operations. (Under homeless supervision.)

5) Showing children the preciousness of life through action.

Every year, many kids pick up dozens of kittens and bring them to the homeless in the park to try and save them from the city health center where they will be killed. This is because the parents won't accept kittens at home. Even at school, the school teacher is helpless. This leads to action by many kids who ask the homeless to take care of the kittens. With these facts in mind, even if the park is renewed, the kids will be heart broken when they find out how the animals were treated. Afterall, the kids learn the preciousness of life not by words, but how we act.

With these facts in mind, we strongly demand this project to be fair for all living lives, and hope this project will be respectable in all matters.
